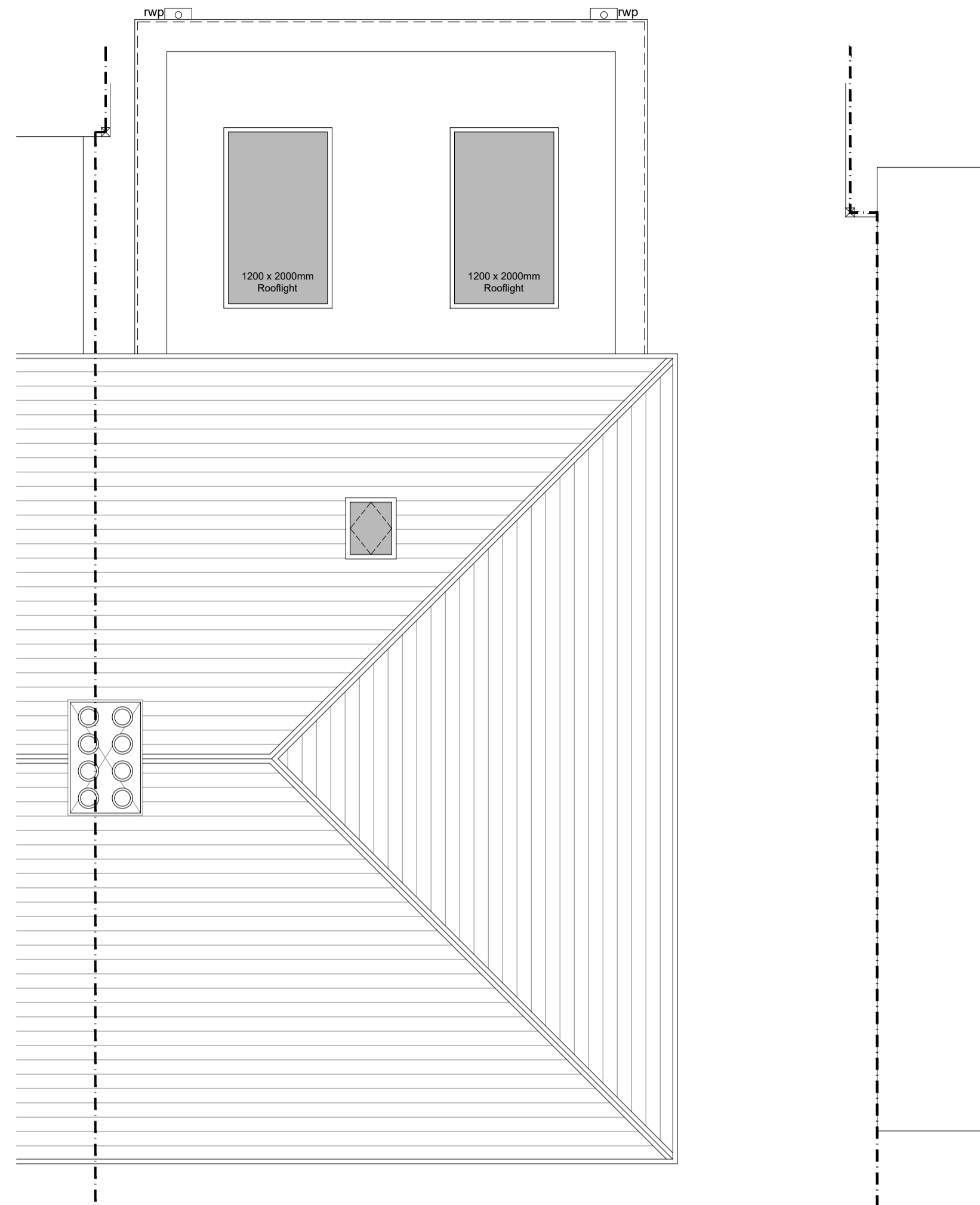

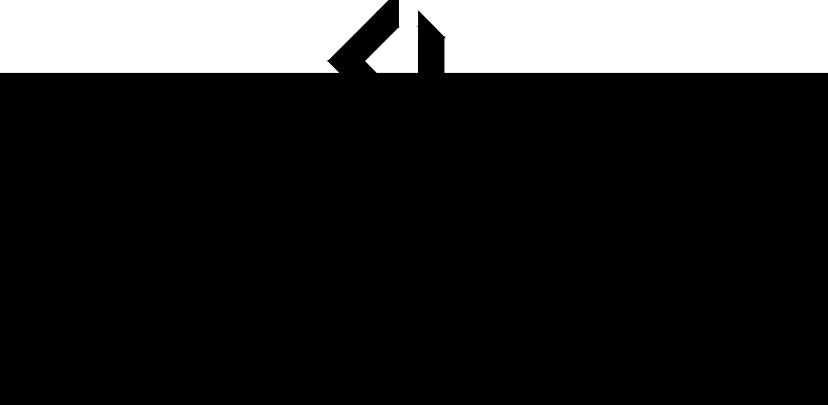

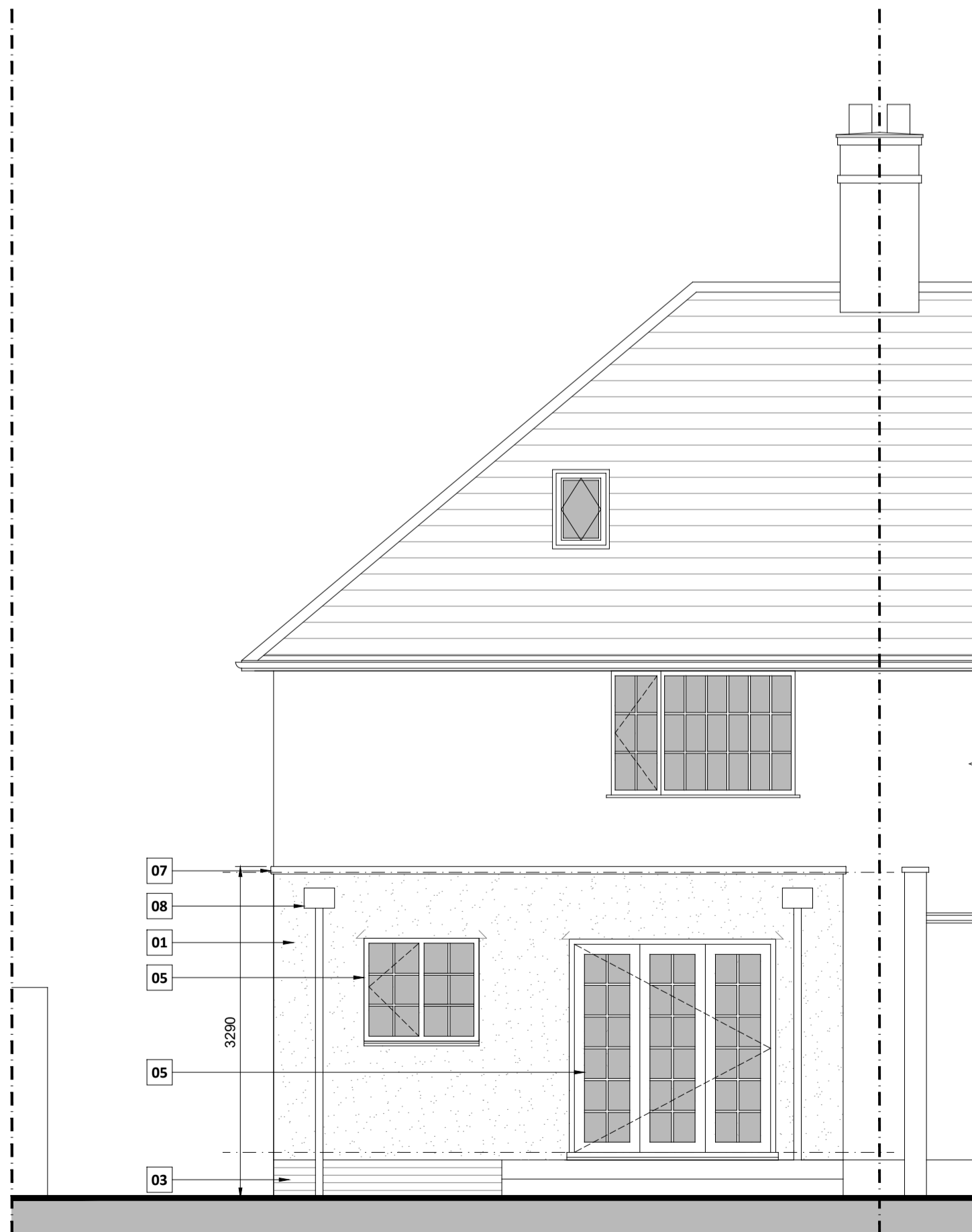

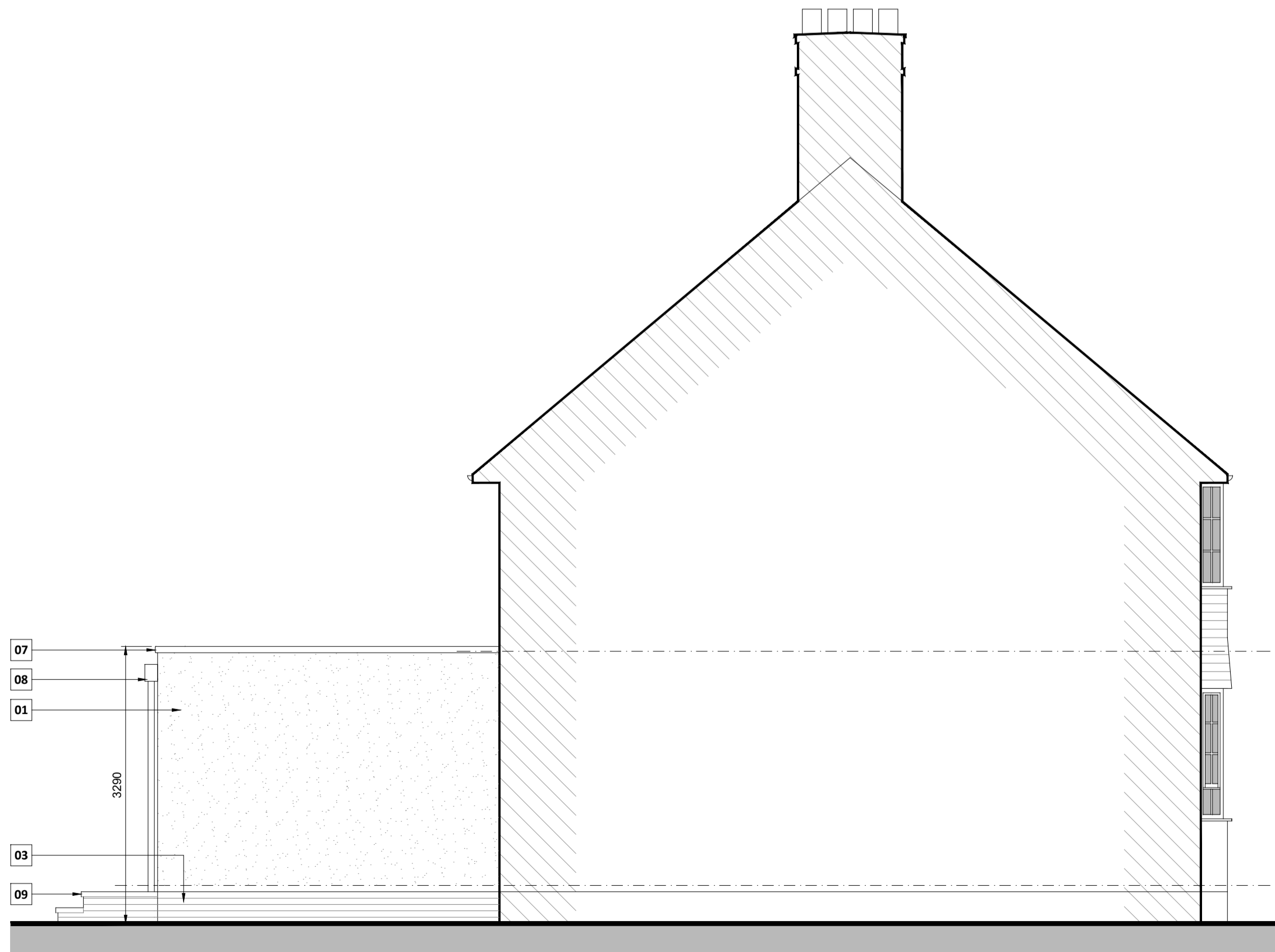
PROPOSED FRONT ELEVATION (WEST)

- 01 - Walls**
Pebble dash render, to match existing.
- 02 - Walls**
Timber cladding, natural stain.
- 03 - Walls**
Brickwork, to match existing.
- 04 - Flat Roof**
Single ply membrane / GRP, Colour Dark Grey.
- 05 - Windows & Doors**
Upvc or aluminium, to match existing.
- 06 - Rooflights**
Upvc or aluminium, Colour Dark Grey.
- 07 - Coping**
Eurodec coping stone, Colour Sand.
- 08 - Rain Water Goods & Downpipes**
Upvc, Colour to match existing.
- 09 - External steps**
Concrete slabs with brick sides and risers, to match existing.
Existing cracked pebble dash render finish to be made good.
